#### SUMMARY ANNUAL REPORT FOR THE 403(B) RETIREMENT PLAN (#001)

This is a summary of the annual report for the Hampshire College 403(b) Retirement Plan, EIN 04-6130872, Plan No. 001, for the period January 1, 2014 through December 31, 2014. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Plan expenses were \$7,081,745. These expenses included \$24,450 in administrative expenses, and \$7,057,295 in benefits paid to participants and beneficiaries. A total of 1,090 persons were participants or beneficiaries of the plan at the end of the plan year.

The value of the plan assets, after subtracting liabilities of the plan, was \$123,678,693 as of December 31, 2014, compared to \$118,322,600 as of January 1, 2014. During the year the plan experienced an increase in net assets of \$5,356,093. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$12,437,838. Income includes employer contributions of \$2,207,504, employee contributions (including rollovers) of \$3,431,044, other income of \$28,880, and earnings from investments of \$6,770,410.
