Summary Annual Report

for the Hampshire College 403(b) Retirement Plan

This is a summary of the annual report for the Hampshire College 403(b) Retirement Plan, EIN 04-6130872, Plan No. 001, for the period January 1, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance contracts and a custodial account agreement. Plan expenses were \$14,781,561. These expenses included \$36,573 in administrative expenses, and \$14,744,988 in benefits paid to participants and beneficiaries. A total of 1,136 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of the plan assets, after subtracting liabilities of the plan, was \$145,483,095 as of December 31, 2019, compared to \$133,675,953 as of January 1, 2019. During the year the plan experienced an increase in net assets of \$11,807,142. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$26,588,703, including employer contributions of \$1,424,708, employee contributions (including rollovers) of \$3,322,790 other income of \$46,372, gains of \$17,885,886 from sale of assets bought and sold, as well as, held during the year, and earnings from investments of \$3,908,947.
