

**SUMMARY ANNUAL REPORT FOR
TRUSTEES OF HAMPSHIRE COLLEGE HEALTH PLAN**

This is a summary of the annual report of the TRUSTEES OF HAMPSHIRE COLLEGE HEALTH PLAN (Employer Identification Number 04-6130872, Plan Number 509) for the plan year 01/01/2019 through 12/31/2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has an insurance contract with Blue Cross Blue Shield of Massachusetts, Inc to pay certain Health, Prescription Drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2019 were \$3,312,660.

Because it is a so called "experience-rated" contract, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2019, the premiums paid under such "experience-rated" contract were \$3,312,660 and the total of all benefit claims paid under the experience-rated contract during the plan year was \$3,025,381.
