The Trustees of Hampshire College Health Plan has contracts with Tufts Associated Health Maintenance Org., Inc. and Tufts Insurance Company to pay health claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2016 were \$3,740,800.

**SUMMARY ANNUAL REPORT FOR DELTA DENTAL PLAN (# 513)**

The Trustees of Hampshire College Dental Plan has contracts with Delta Dental of Massachusetts to pay dental claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2016 were \$235,208.

**SUMMARY ANNUAL REPORT FOR HM LIFE INSURANCE COMPANY PLAN (VISION) (# 514)**

The Trustees of Hampshire College Vision plan has contracts with HM Life Insurance Company to pay vision claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2016 were \$16,353.
