SUMMARY ANNUAL REPORT FOR THE HAMPSHIRE COLLEGE 403(B) RETIREMENT PLAN (#001)

This is a summary of the annual report for the Hampshire College 403(b) Retirement The Employee Retirement Income Security Act of 1974 (ERISA) requires annual notification of information known as a Summary Annual Report, on financial information filed with the Internal Revenue Service and the U.S. Department of Labor for the following plans in which you are a participant.

Plan, EIN04-6130872, Plan No. 001, for the period January 1, 2011 through December 31, 2011. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Plan expenses were \$6,010,813. These expenses included \$50 in administrative expenses, and \$6,010,763 in benefits paid to participants and beneficiaries. A total of 1,048 persons were participants or beneficiaries of the plan at the end of the plan year.

The value of the plan assets, after subtracting liabilities of the plan, was \$93,245,120 as of December 31, 2011, compared to \$93,346,600 as of January 1, 2011. During the year the plan experienced a decrease in net assets of \$101,480. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$5,909,333, including employer contributions of \$1,932,118, employee contributions (including rollovers) of \$3,312,586, and earnings from investments of \$664,629.

The Plan has a contract with Standard to pay all claims incurred under the terms of the plan. The total premiums paid for the period of October 1, 2009 through September 30, 2010 were \$106,212.
