### SAMPLE ORAL CONSENT

Because the interview engages participants in thinking about non-violent conflict resolution, there are potential benefits to your ability to handle real-life situations of conflict."

### Freedom to Withdraw or Refuse Participation:

"You have the right to stop watching the tape at any time, or to refuse to answer any of my questions without prejudice from me or others related to this research."

## **Grievance Procedure:**

"If you have any concerns or are dissatisfied with any aspect of this study you may report these concerns anonymously to the Human Subjects Institutional Review Board. I can provide you with a mailing address and/or phone number at anytime so you can report your concerns"
