## Faculty Involvement in Alumni Engagement and Fundraising

- Faculty members Margaret Cerullo, Sue Darlington, Marlene Gerber-Fried, Viveca Greene, Jill Lewis, and Lise Sanders are reaching out to alums in support of the Hampshire Fund via the Feminist Faculty Giving Initiative. As of March 7th, the initiative has garnered \$15,240 in gifts from 58 contributors. An anonymous donor has also pledged a \$1 to \$1 matching gift of up to \$30,000.

### **New Gifts and Grants**

Trustee Gaye Hill and her husband Jeffrey Urbina, parents of a Hampshire alum, have pledged a one million dollar challenge gift to support financial aid at Hampshire College. Receiving the full gift is contingent upon two requirements: first, that the money be applied toward creating a diverse and respectful community, increasing the financial aid available to students; and second, that the College increase parent and alumni participation and raise an additional \$1 million in unrestricted funds.

In addition, at the February board meeting, trustees Bob McCarthy 72F and David Dinerman 72F stepped forward with pledges totaling \$600,000. Their gifts are targeted toward core strategic priorities, including student financial aid, endowment for the Baldwin Scholars program, and enhancements to the operations of the admissions office.

Christopher Young, 73F, has pledged \$60,000 over three years for music-program renovations.

Sarah Goldfinger, 94F, has established a new endowment fund to support a playwriting practicum that will allow Hampshire to send students to see Broadway shows, and will bring visiting playwrights to work with students on campus.

An anonymous trustee has made a gift to underwrite the costs of developing a new peer training program for students in oral presentation skills. The training is being coordinated by the Dean of Faculty office in collaboration with Mt. Holyoke's Speaking, Arguing and Writing program, to take place this spring for Division III students.
