The Jerome Liebling Memorial Fund



The Jerome Liebling Memorial Fund has been established to honor Jerome Liebling's life and legacy as a pioneering photographer, filmmaker, and teacher. This endowed fund will provide opportunities for Hampshire College alumni with expertise in the academic and professional areas Professor Liebling mentored and taught to share their professional work and experiences with students, faculty, and the greater Hampshire community. It will support classroom and laboratory experiences and provide Hampshire students with opportunities to supplement their studies through participation in specialized workshops, seminars, and other means of engagement.

The Jerome Liebling Memorial Fund will also support the ongoing renewal and modernization of the Liebling Center for Film, Photography, and Video. Dedicated in 2009, the building has been certified by the U.S. Green Building Council at the Gold Level for energy efficiency and environmental design. The fund will help keep this state-of-the-art facility at the forefront of "green" buildings and Hampshire's film, photography, and video program at the technological and pedagogical leading edge.

The Jerome Liebling Memorial Fund has been established entirely through donations from family, friends, and the generations of students whose careers, creativity, and artistic vision were shaped by their connection to Jerry Liebling in the classrooms, darkrooms, and studios where he taught, lectured, and critiqued.

New Gifts and Grants

The Andrew W. Mellon Foundation recently awarded Hampshire College \$850,000 over three years for the proposal, “Bridge to Retirement: Facilitating Institutional Change.” The funding will be used to create a next-generation model of innovative, interdisciplinary education, connecting professors who are retiring or who wish to transition into retirement with newer professors.

An anonymous foundation granted Hampshire \$383,612 to support environmental and sustainability programs.

The National Science Foundation awarded Hampshire College \$181,159 as part of a \$1 million grant for the proposal “NSF UBM—Collaborative Research: Four College BioMath Consortium.” Hampshire computer science professor Lee Spector and math professor Sarah Hews join with faculty from Amherst, Smith, and Mount Holyoke Colleges to create a multi-campus biomathematics community dedicated to training young scholars to make major contributions to the emerging field of the interface between biology and mathematics. *Right: Math professor Sarah Hews.*

Robert Lisle M.D. donated \$10,000 to establish the Robert Lisle History of Photography Fund. The fund will support the cataloguing, labeling, archiving, and filing of the Robert Lisle History of Photography collection: a rich and diverse collection of objects in the history of photography, including cameras, viewers, photographs, photographic books, posters, publications, and other forms of photographic ephemera.

1. Group Improvisation: Exploring Creative Dance

Now in its sixth year at Hampshire College, this course carries on the legacy of pioneering creative dancer Barbara Mettler. Mettler-based dance is a style of creative dance that reflects the Zuni phrase “We dance both for pleasure and for the good of the city.” Coordinated in large part by Daphne Lowell, co-coordinator for the Hampshire College Dance Program, this class is made possible entirely by donations from friends of Mettler-based creative dance around the world.
